BID SPECIFICATIONS & CONDITIONS

BID CONDITIONS:

1. Bid Opening will be conducted on **Thursday, June 3, 2024**, at **10:00 a.m.** at Paris City Hall.
  - a. All Bidders must be licensed and eligible to perform business operations in the State of Tennessee.
  - b. The opaque sealed envelope should be clearly marked: "Hot Mix, Chert Gravel, Limestone Gravel, Limestone Rip Rap and the Milling, Binder, Resurfacing with Hot Mix Asphalt and Striping of City Streets; Concrete Products; and Tree Trimming & Debris Hauling"
  - c. All Bids must be submitted to:

  - d. Any questions regarding the proposed contract shall be addressed to the Paris City Manager at the above address or by email to Jessica Crouch, [jcrouch@cityofparistn.gov](mailto:jcrouch@cityofparistn.gov). Any interpretations rendered to any Bidder shall be rendered to all Bidders who have obtained a bid package.
  - e. All bids shall be publicly opened and are subject to public inspection.
  - f. All bids must be signed by a duly authorized representative of the company empowered with the legal right to bind the company. Failure to comply with this requirement shall be cause for rejection of the bid.



General Conditions:

1. Qualifications of Bidder: The City of Paris may make such investigation as it deems necessary to determine the ability of the bidder to perform the work, and the bidder shall furnish to the City all such information and data for this purpose as the City may request. The City of Paris reserves the right to reject any bid if the evidence submitted by, or investigation of, such bidder fails to satisfy the City that such bidder is properly qualified to carry out the obligations of the contract and to complete the work contemplated therein. Conditional bids will not be accepted. Any contract resulting from this request for proposals shall be awarded based on the lowest bid in combination with the City's evaluation of the contractor's capacity to successfully complete the contract.
2. Insurance: The contractor shall not commence work under this contract until having obtained all the insurance required under this paragraph and such insurance has been approved by the City, nor shall the contractor allow any subcontractor to commence work until said insurance has been obtained and approved.
  - a. Workman's Compensation Insurance: The contractor shall procure and shall maintain during the life of this contract Workman's Compensation Insurance as required by applicable State Law for all of his employees to be engaged in work at the site of the project under this contract and, in case of any such work sublet, the contractor shall require the subcontractor similarly to provide Workmen's Compensation Insurance for all of the latter's employees to be engaged in such work unless such employees are covered by the protection afforded by the contractor's Workmen's Compensation Insurance. In case any class of employees engaged in hazardous work on the project under this contract is not protected under the Workmen's Compensation Statue, the contractor shall provide and shall cause each subcontractor to provide adequate employer's liability insurance for the protection of his employees that are not otherwise protected.
3. Proof of Carriage of Insurance: The contractor shall furnish the City with certificates showing the type, amount, class of operations covered, effective dates and date of expiration of policies. Such certificates shall also contain substantially the following statement: "The insurance covered by this certificate will not be cancelled or materially altered, except after ten (10) days written notice has been received by the City."
4. Termination Clause: In the event that any of the provisions of this contract are violated by the contractor, or by any of his subcontractors, the City may serve written and/or verbal notice upon the contractor and the Surety of its intention to terminate the contract, such notices to contain the reason for such intention to terminate that contract, and unless immediately after the serving of such notice upon the contractor, such violation or delay shall cease and satisfactory arrangement of correction be made, the contract shall cease and terminate. In the event of any



such termination, the City shall immediately serve written or verbal notice thereof upon the contractor.

5. Indemnify and Hold Harmless: The contractor shall indemnify and hold harmless the City and its agents and employees from and against all claims, damages, losses, and expenses including attorney's fees arising out of or resulting from the performance of the work, provided that any such claims, damage, loss or expenses is attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property, including the loss of use resulting therefrom; and is caused in whole or in part by any negligent or willful act or omission of the contractor, and subcontractor, anyone directly or indirectly employed by any of them or anyone for whose acts any of them may be liable.
  
6. Contract Document: The contractor shall agree to sign a contract document, once awarded bid, which would include the herein contained General and Special Conditions.



Special Conditions:

1. Scope:

- a. The work under this contract includes Hot Mix, Chert Gravel, Limestone Gravel, Limestone Rip Rap and the Milling, Binder, Resurfacing with Hot Mix Asphalt and Striping of City Streets; Concrete Products; and Tree Trimming & Debris Hauling. The Paris Public Works Department is located at 317 East Washington Street, Paris, TN 38242.

2. Inspection:

3. Specifications:

- a. The contractor shall carefully examine the sites of the work to acquaint himself with all working conditions and all difficulties that may be involved in the work to be performed.
- b. All Bid Prices must be good until June 30, 2025.
- c. The submission of a proposal to the City shall be accepted as evidence that such examinations have been made, and that all difficulties encountered have been provided for in this proposal. Later claims for extra compensation will therefore not be recognized by the city.

4. Work to be Performed:

- a. 411 D or E Hot Mix Free on Board (F.O.B.):
  - i. To be picked up by the City of Paris Public Works Department.
  - ii. This mix must be mixed according to the Tennessee Department of Transportation (TDOT) Specifications for Road and Bridge Construction, March 1, 1981.
  - iii. All mix must meet the job mix formula designed by TDOT.
  - iv. The mix must be pre-inspected and approved.
  - v. All materials will be graded and will meet the State Specifications for the use of State Aid Streets as well as all other necessary projects negotiated by the City of Paris.
  - vi. The mix will be F.O.B. at the plant to be picked up and loaded on City of Paris Department of Public Works trucks.



- vii. In evaluating the bids, the City of Paris will add .48¢ per mile of distance to the plant, via best and most direct route, to the base per ton bid.

b. Chert Gravel F.O.B.

- i. To be picked up by the City of Paris Public Works Department.
- ii. Chert Gravel must meet Tennessee State Specifications for Road and Bridge Construction, March 1, 1981, for Type B Base, Chert, Grading C or D, Pit and Chunk.
- iii. In evaluating the bids, the City of Paris will add .48¢ per mile of distance to the plant, via best and most direct route, to the base per ton bid.

c. Resurfacing City Streets with Hot Plant Mix Asphalt:

- i. The City of Paris Department of Public Works is taking bids for hot plant mix asphalt per ton in place.
- ii. The hot mix plant mix asphalt must be mixed and placed in accordance with the Tennessee Department of Transportation Specifications.
- iii. The mix shall be 411 D or E hot plant mix asphalt meeting the requirements of the Tennessee Department of Transportation Specifications.
- iv. The Contractor will be responsible for a state approved job mix design and any other testing as may be necessary in the performance of the work.
- v. The Contractor will be responsible for all traffic control and safety on each project.
- vi. The roads to be resurfaced must be cleaned, tacked, patched, and leveled (or brushed) by the contractor.
- vii. The Contractor shall have pavers with gates that tilt, due to our existing curb and gutter construction.
- viii. The roads are to be paved with approximately one-hundred and fifty (150) pounds per square yard. The total pounds per square yard of hot plant mix asphalt must not exceed one-hundred and seventy-five (175) pounds per project.
- ix. The Contractor shall be responsible for clipping grass along the sides of the road in preparation of paving.
- x. The City of Paris Department of Public Works will be responsible for manholes, water valves, and catch basins on each project.
- xi. The completion of the projects will be ninety (90) working days from the time the City of Paris Department of Public Works contract is awarded.
- xii. The City of Paris Department of Public Works reserves the right to delay the beginning of any project due to revenue on hand.
- xiii. Any changes in these specifications by the City of Paris or the Contractor, (after the jobs have been awarded), must be submitted in writing.
- xiv. Milling – City to remove milled product at their sole discretion. Contractor must remove remainder from site. Contractor is also responsible for site clean-up.



d. Resurfacing City Streets with Binder Asphalt (Base):

- i. The City of Paris Department of Public Works is taking bids for binder asphalt per ton in place as a base beneath surface mix.
- ii. The binder asphalt must be mixed and placed in accordance with the Tennessee Department of Transportation Specifications.
- iii. The mix shall be binder asphalt meeting the requirements of the Tennessee Department of Transportation Specifications.
- iv. The Contractor will be responsible for a state approved job mix design and any other testing as may be necessary in the performance of the work.
- v. The Contractor will be responsible for all traffic control and safety on each project.
- vi. The roads to be resurfaced must be cleaned, tacked, patched, and leveled (or brushed) by the contractor.
- vii. The Contractor shall have pavers with gates that tilt, due to our existing curb and gutter construction.
- viii. The roads are to be paved with approximately one-hundred and fifty (150) pounds per square yard. The total pounds per square yard of binder asphalt must not exceed one-hundred and seventy-five (175) pounds per project.
- ix. The Contractor shall be responsible for clipping grass along the sides of the road in preparation of paving.
- x. The City of Paris Department of Public Works will be responsible for manholes, water valves, and catch basins on each project.
- xi. The completion of the projects will be ninety (90) working days from the time the City of Paris Department of Public Works contract is awarded.
- xii. The City of Paris Department of Public Works reserves the right to delay the beginning of any project due to revenue on hand.
- xiii. Any changes in these specifications by the City of Paris or the Contractor, (after the jobs have been awarded), must be submitted in writing.
- xiv. Milling – City to remove milled product at their sole discretion. Contractor must remove remainder from site. Contractor is also responsible for site clean-up.

e. Limestone F.O.B.:

- i. To be picked up by the City of Paris Public Works Department.
- ii. Stone must meet State and Federal Road Specifications.
- iii. Limestone D Grade 33 C.
- iv. 57" Gravel.
- v. 8" Rip Rap 90 pound.
- vi. 6" Rip Rap 49 pound.
- vii. Stone must be pre-inspected at Quarry.
- viii. In evaluating the bids, the City of Paris will add .48¢ per mile of distance to the plant, via best and most direct route, to the base per ton bid.





f. Center Line Marking and Striping:

- i. Bids shall be on four (4) inch line per lineal mile. Paint and beads will meet or exceed Tennessee DOT Specifications. Seventeen (17) gallons of paint per mile with no less than six (6) pounds of beads per gallon of paint shall be used.
- ii. Bid price shall include all labor and material to apply the striping and all traffic control.
- iii. All striping shall be done on an as needed basis.

g. Concrete:

- i. Concrete shall meet all TDOT specifications.
- ii. Price per yard:
  - 4000 PSI
- iii. Bid on Front Truck Loader

h. Tree Trimming and Debris Hauling:

- i. Tree trimming in specified areas in the City of Paris, AND removal of all debris to the Paris-Henry County Landfill, per Public Works Department by a licensed, bonded, and insured company. Must furnish certificate of insurance with bid.
- ii. Bidding will be by the individual job (NOT HOURLY) for trimming and removal. MUST include landfill fees. For more information, please contact Phillip Jessie @ 731-641-1485.
- iii. The completion of the projects will be ninety (90) working days from the time the City of Paris Department of Public Works contract is awarded.
- iv. Tree Trimming in 2024-2025 will be Zone 1 and Zone 9 (map attached on page 16).

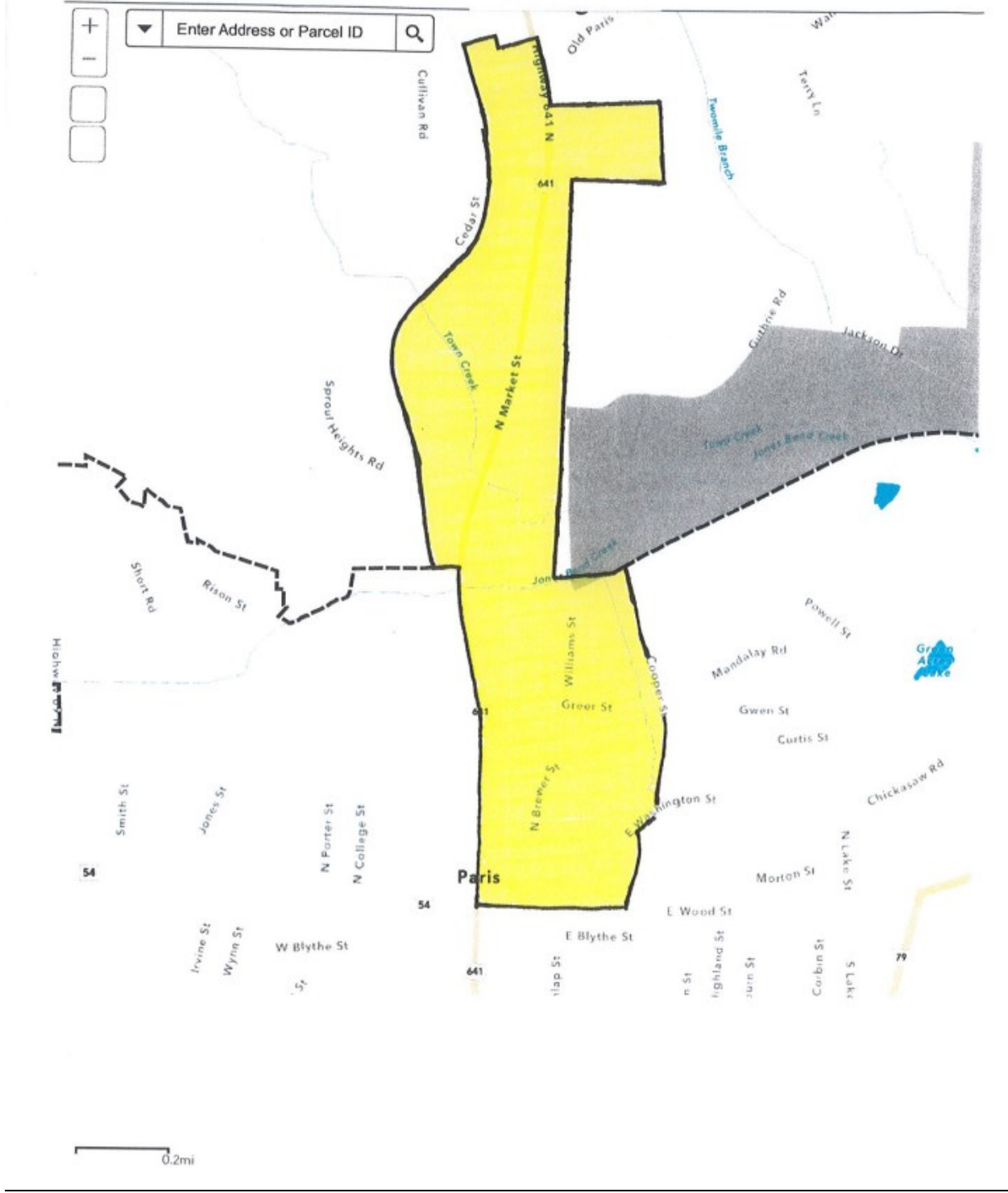


*TREE TRIMMING MAP ZONES 2024 - 2025*

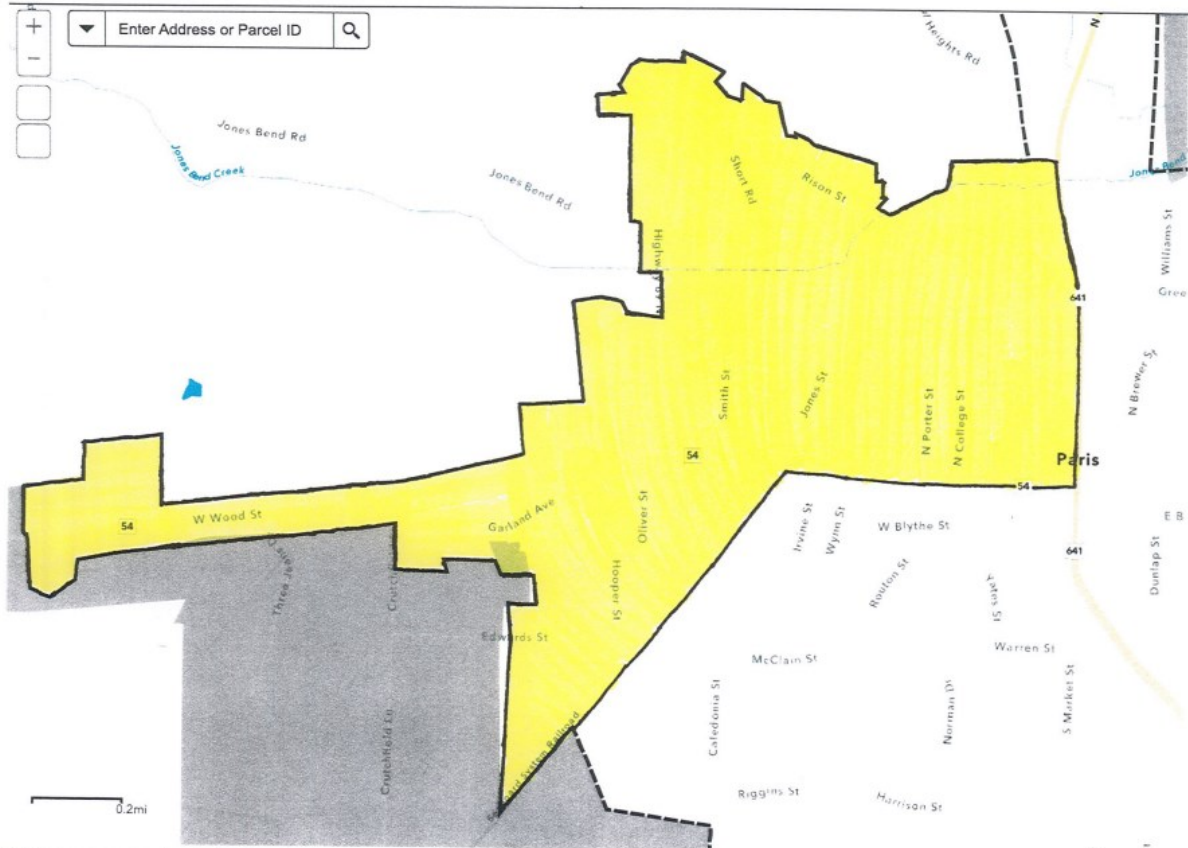
